During fiscal year 2021, screening for food insecurity began in August at the 4 pilot sites (NOAH's Palomino and Heuser clinics and HonorHealth Medical Group's North Phoenix and Carefree clinics). For our SDOH strategic priorities for 2023, our goal is to develop ACO outcomes report for SDOH using the Unite US referral platform - to assess the impact of SDOH screening and closing the loop (connecting patients who screen positive for SDOH with resources in the community). The partnership with Unite Us was recently launched and Innovation Care Partners have continuously been building the platform entering community-based organizations for patient referrals.
